# **Live Greenery**

#### From the Desk of Social Services

It has been brought to my attention that a few residents and family members have been asking about the new legislation going into effect on January 1, 2020 regarding cameras and monitoring devices. The new legislation is very lengthy, but I will try to summarize it here. The entire regulation can be found at: https://www.revisor.mn.gov/statutes/cite/144.6502

Legislators wanted information about granting permission to place video cameras in resident rooms for the purpose of protection from abuse and/or neglect. A work group was established to create recommendations for legislation that authorizes the use of voluntary electronic monitoring to protect vulnerable adults and hold accountable perpetrators of abuse.

In order to place a monitoring device in a resident room, very specific consent must be provided by the resident and his/her roommate (if applicable) before monitoring can begin. If a resident gets a new roommate, the new roommate needs to sign the consent form if the monitoring is acceptable to him/her. If the roommate refuses to consent, the facility shall make a reasonable attempt to accommodate the resident who wants to conduct electronic monitoring. This means that the resident who wants to do the electronic monitoring would be offered a different room if available. If a room isn't immediately available, the facility will reevaluate the request every two weeks. There are some exceptions to the notification and consent which are explained in detail in the above link. The legislation also provides all the information which is required to be on the notification and consent form. We will have forms available January 1st.

A resident who wants electronic monitoring is responsible for all expenses related to equipment, installation, maintenance and removal. The facility is required to post a sign at each facility entrance accessible to visitors that states: "Electronic monitoring devices, including security cameras and audio devices, may be present to record persons and activities." The rest of the regulation has to do with not obstructing the electronic monitoring devices, information about dissemination of recordings, admission of evidence, liability, resident protections, discipline and penalties.
